

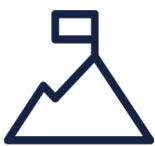

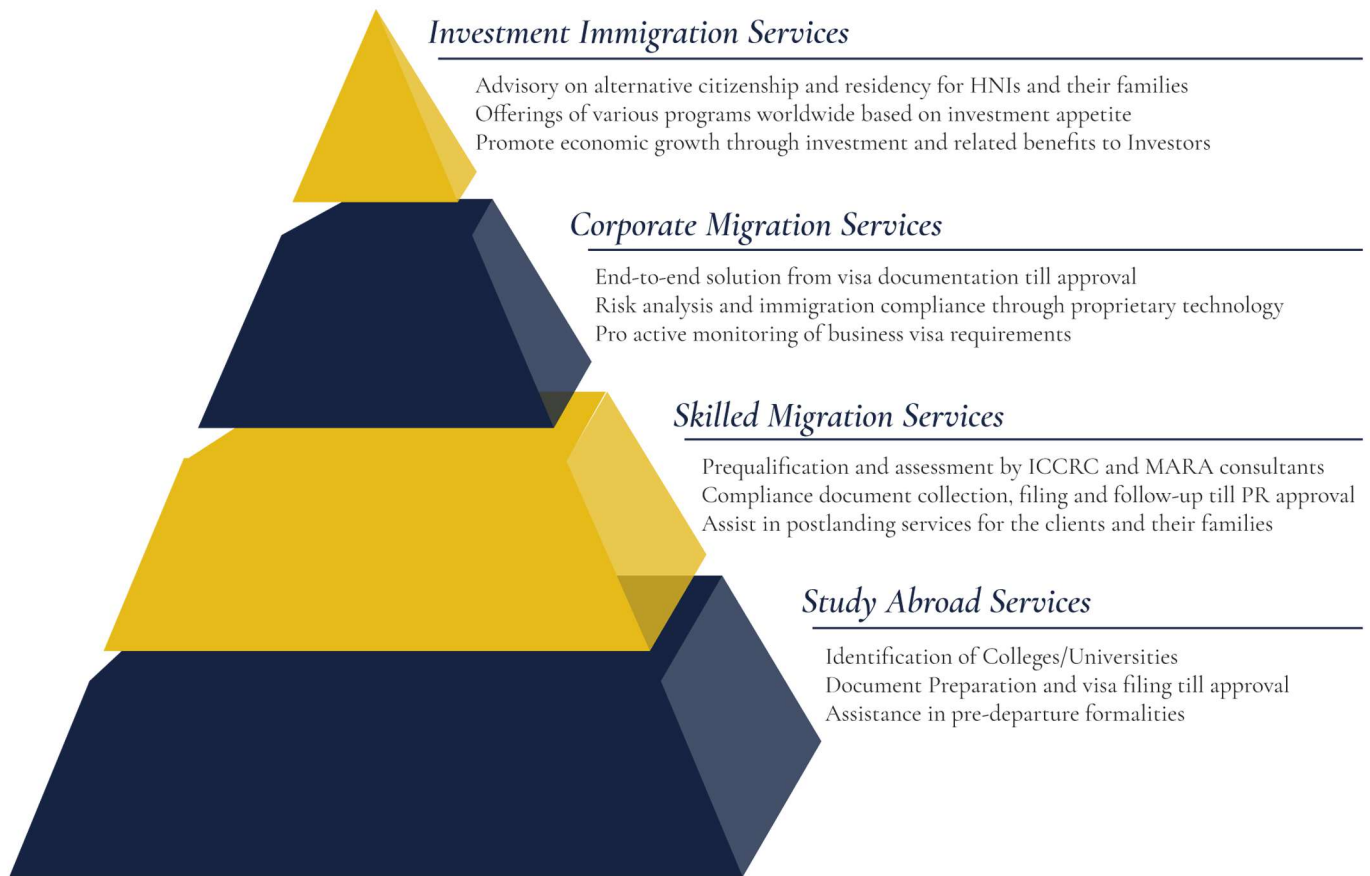

Key details of Quebec Investor Immigration Programme

Description

Quebec's Immigrant Investor Programme is designed to allow business people and their families to enter the province of Quebec as permanent residents on an unconditional basis. In return, funding made available through the program helps provide subsidies in support of Quebec small and medium businesses.

This programme has been reopened from May 29 2017 to February 23 2018. The maximum number of applications that can be received during this period is 1,900.

Investment Criteria

Have, alone or with his accompanying spouse, including de facto spouse, **net assets of at least \$1,600,000 CAN** obtained legally, excluding the amounts received by donation less than six months before the date on which the application was filled.

Intend to settle in Québec and sign an agreement to invest **\$800,000 CAN** with a financial intermediary (broker or trust company) authorized to participate in the Investor Program.

The investment to be locked in for a period of 5 years without any interest payment.

Timeline

Visa approval in 9 months. Permanent Residence in an additional 12 months.

Eligibility

Citizens of all nationalities with good standing and clean records.

Have experience in management in a legal farming, commercial or industrial business, or in a legal professional business where the staff, excluding the investor, occupies at least the equivalent of two full-time jobs, or for an international agency or a government or one of its departments or agencies.

<i>Eligibility</i>	<p>Investor who is</p> <p>Successful and experienced: Knowledgeable and have a strong background in the proposed sector of business in B.C</p> <p>Investment-ready: Have investment funds, and are ready to execute the business proposal</p> <p>Prepared: Understands how they can make proposed business profitable, the risks, the local business conditions and the required resources</p> <p>Confident and Adaptable: Have confidence in business ventures and can demonstrate the due diligence, have been undertaken to fully understand the local business environment</p>
