



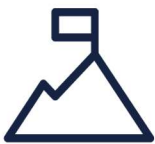

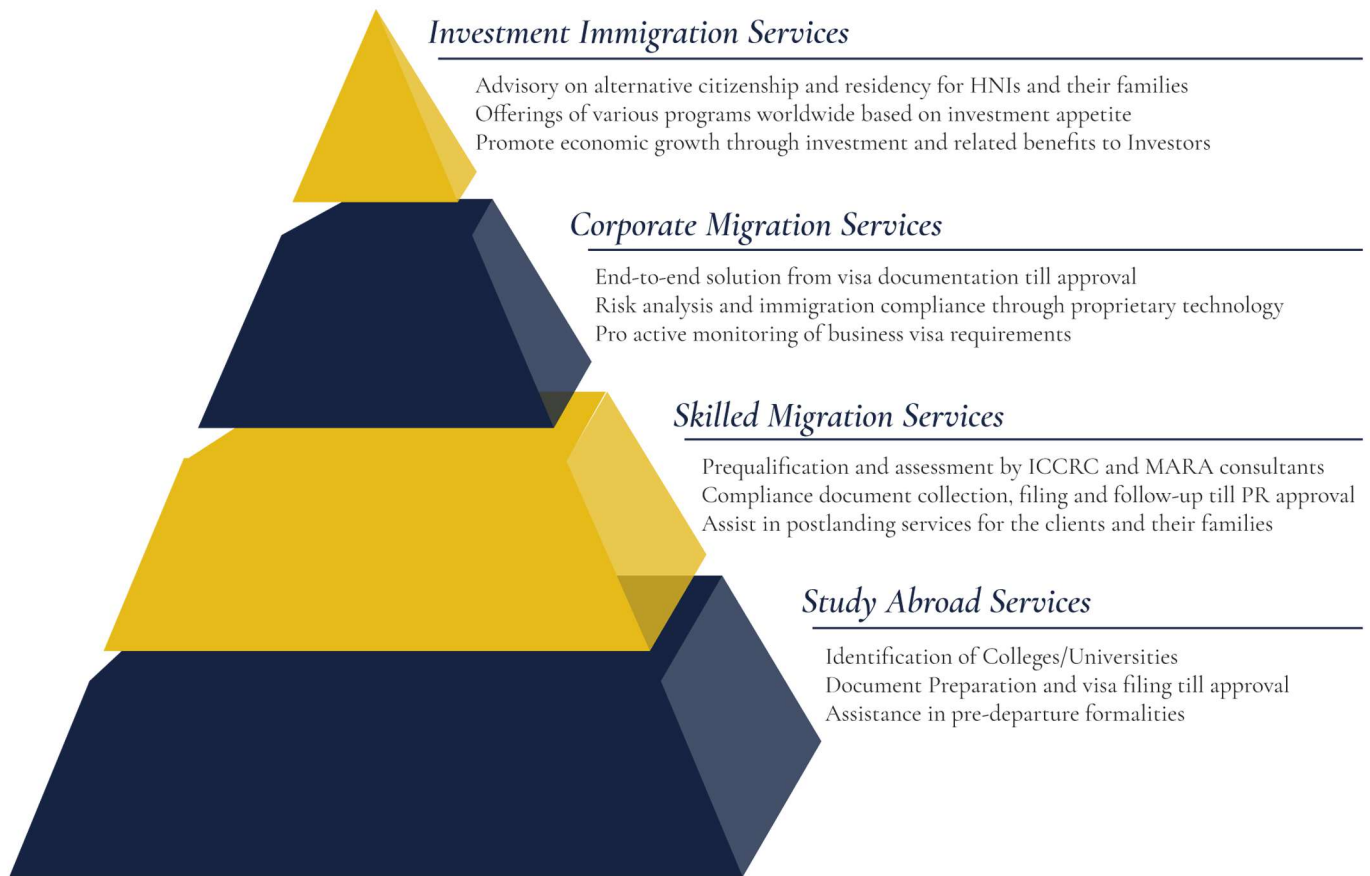

## Key details of Malta Individual Investor Programme

<i>Description</i>	The Individual Investor Programme of the Republic of Malta (IIP), by virtue of Legal Notice 47 of 2014, allows for the granting of citizenship by a certificate of naturalisation to individuals and their families who contribute to the economic and social development of Malta.
<i>Investment Criteria</i>	<p><b>Contribution to Malta Economy -</b> The making of a contribution to the Maltese Economy by means of a non-refundable contribution of €650,000 by the main applicant.</p> <p><b>Real Estate -</b> The investor should have a property purchase in Malta with min €350,000 (excl. VAT) or lease property of €16,000 per annum rent.</p> <p><b>Investment in financial assets of Government bonds -</b> An investment in stocks, bonds or special purpose vehicles to be identified by Identity Malta, for a minimum value of €150,000.</p>
<i>Lock-in-Period</i>	<p>The contribution amount is lifetime and non-refundable.</p> <p>The investor is obliged to retain the investment for at least 5 years in case of government approved financial instruments and property purchase.</p> <p>The investor is obliged to buy a property after 5 year period in case of leased property with min €12,000 per annum to renew the residence permit.</p>
<i>Timeline</i>	3-4 months for PR / 10-12 months for Citizenship

## Benefits of Malta Citizenship

- An express procedure in obtaining an EU passport with passport issued within 1 year
- Citizenship is granted to the parents, spouse and dependent children of the investor
- Low government fees for the filing of the application
- Access to all rights of an EU citizen protected by EU legislation and regulations
- VISA-free travel to over 160 countries worldwide
- Taxation rates are very competitive with resident non-domiciled individual in Malta, only liable for Capital Gains tax arising from gains in Malta and on income outside of Malta but received in Malta
- Children over the age of 27 at the time of application can be included, and that children do not lose the residency rights on their 27th birthday and they retain residency rights as long they aren't economically active and/or married at application stage
