

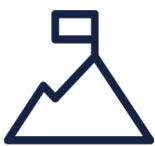

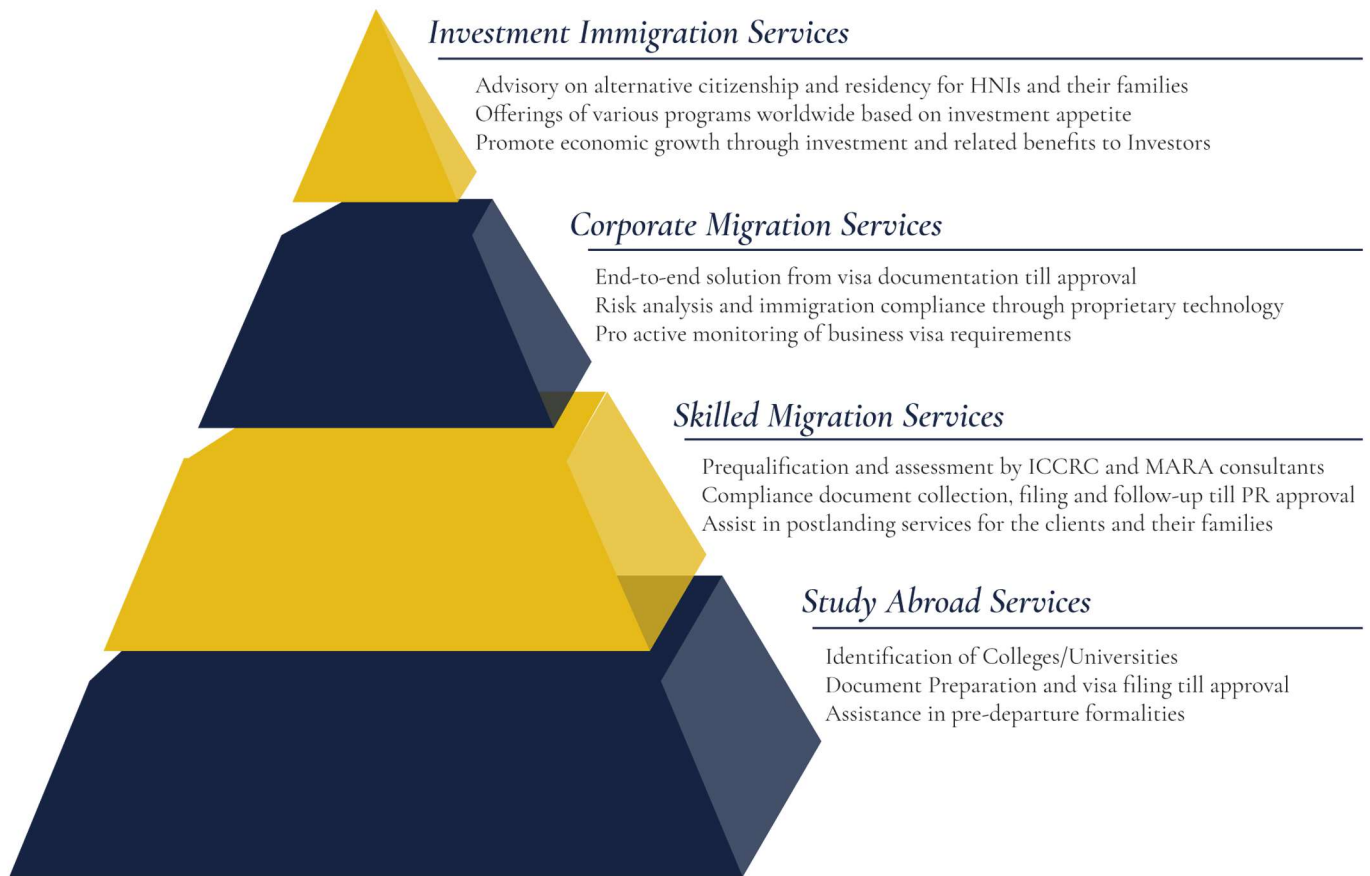

Location

UK is an island nation in Western Europe, with the predominant land area made up of Great Britain and part of islands of Ireland. Close proximity to Europe and US gives it an economical advantage.

Key details of UK Tier1 Investment Programme

<i>Description</i>	The investor category is designed to allow wealthy individuals who make a substantial financial investment in the UK to obtain permission from the UK to enter as an investor under the Tier 1 category. The applicant must invest a minimum of £2 million in the UK
<i>Investment Criteria</i>	<p>Investment in financial assets of Government bonds - The criteria specifies that the applicant must show that they have money of their own under their control in a regulated financial institution amounting to no less than £2 million</p> <p>Accelerated route to permanent residence - An investment of £10 million or more will provide for settlement after two years, and an investment of £5 million or more will provide for settlement after three years, instead of the usual five years</p>
<i>Timeline</i>	The applicant will initially obtain the Tier 1 visa for 40 months . Within three months of entry into the UK, they are required to make the investment of £2 million which must be maintained throughout the period of leave
<i>Eligibility</i>	<p>Non-EU citizens with good standing and clean records</p> <p>Eligible dependents include the spouse, dependent children and dependent parents, as well as, siblings under the care of the main applicant. Children over the age of 18 may also be considered as dependent given they are financially dependent on the main applicant, or enrolled in an academic institution.</p>

Benefits of UK Tier 1 Investor Visa Programme

- There is no requirement to have an English Language qualification
- To apply for accelerated indefinite leave to remain such that, if applicant is able to invest £5million they can secure indefinite leave to remain in three years and if applicant is able to invest £10 million they can secure indefinite leave to remain in two years
- Once the visa is approved dependents would be able to remain outside the UK for up to six months without having any impact on their eligibility to apply for indefinite leave to remain
- As long as the initial amount invested was £2million or more, then there is no need to invest further funds
- There is also no requirement to have any additional funds for maintenance
- Applicant's wife/husband on the dependant visa would be eligible to work/study if he/she wished to do so. Upto 4 main applicants can be included in the application along with 10 dependant family applicants
