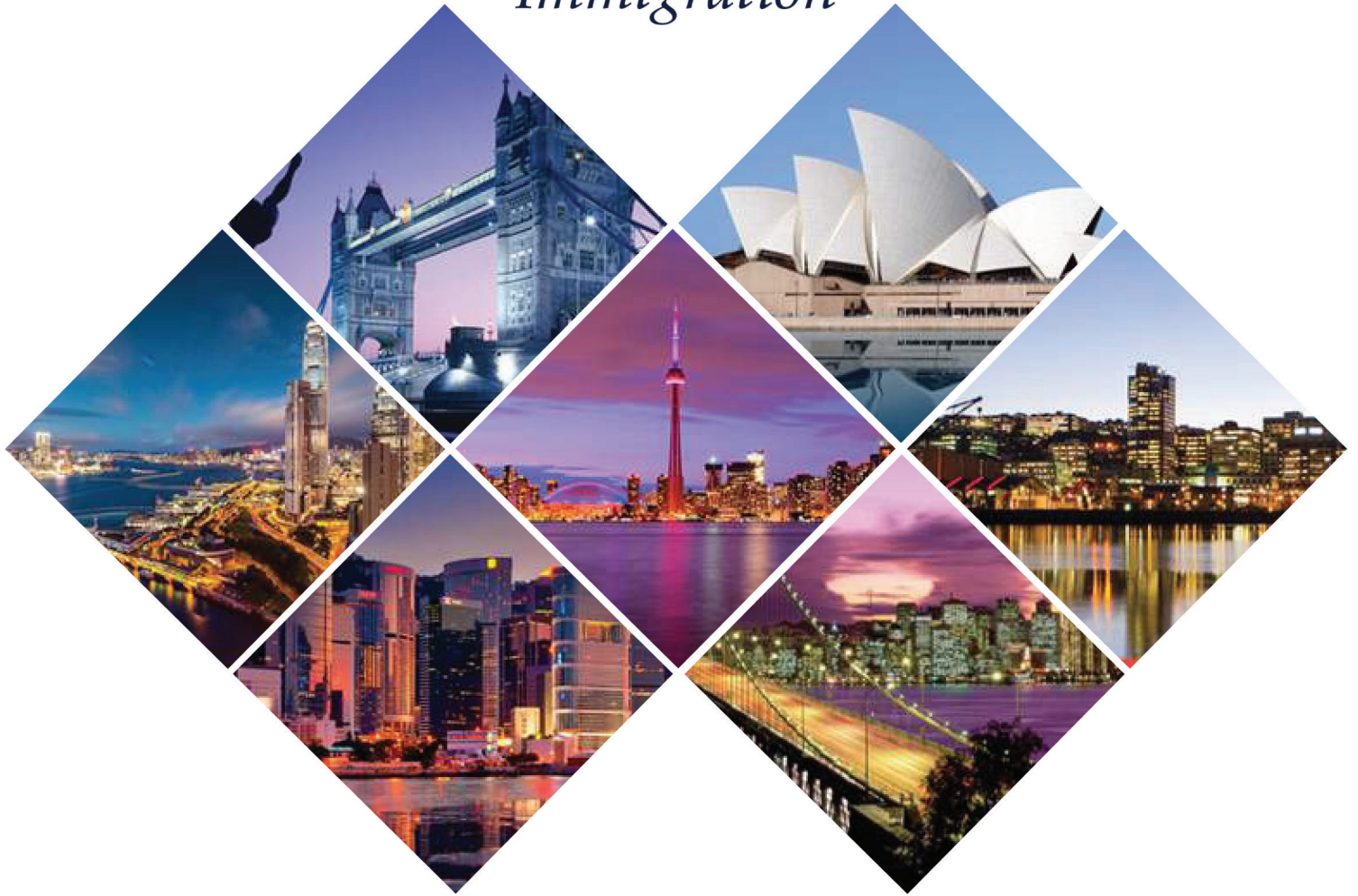

Skilled workers and professionals: Who can apply

Skilled workers are people who are selected as permanent residents based on their ability to become economically established in Canada. Federal skilled worker applications received on or after 30th June 2011 are now assessed for eligibility according to a set of criteria issued by the Minister of Citizenship, Immigration and Multiculturalism. You can find out more about the criteria in the Learn about section at the bottom of this page. Your application will be reviewed in three steps.

According to the eligibility criteria, your application is eligible for processing if:

- you have an offer of arranged employment, OR
- you are a foreign national who has been living legally in Canada for one year as a temporary foreign worker or an international student, OR
- you are a foreign national who has been living legally in Canada for one year as a temporary foreign worker or an international student, OR

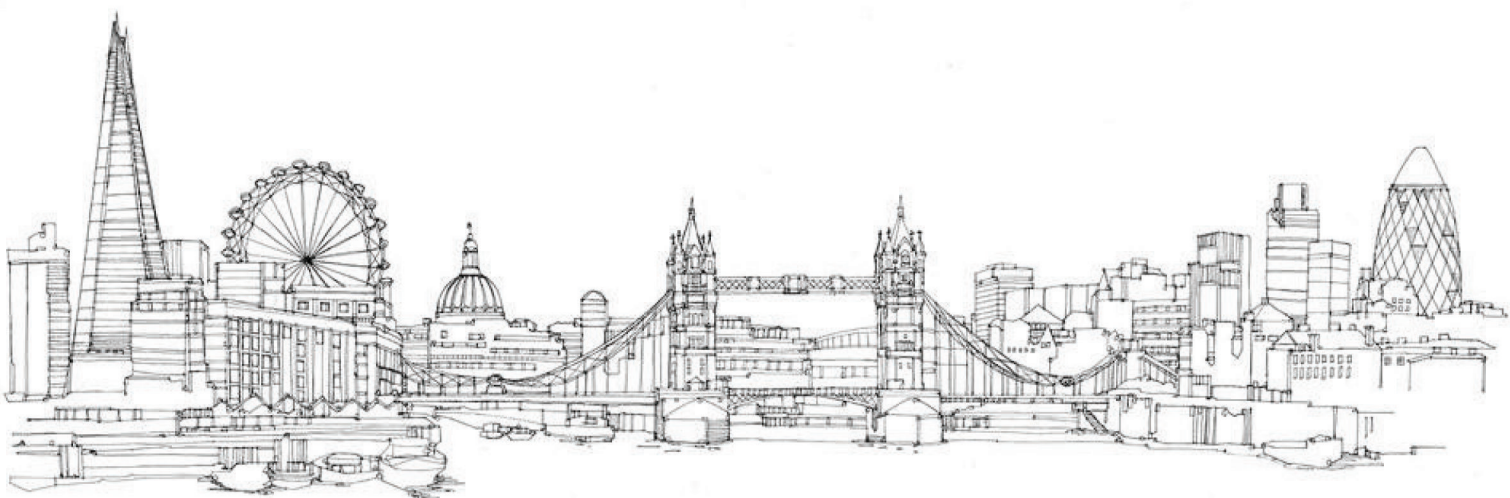
If your application is eligible for processing, you must also meet the following minimum requirements to qualify as a skilled worker:

You have at least one year of continuous full-time paid work experience or the equivalent in part-time continuous employment, AND your work experience must be Skill Type 0 (managerial occupations) or Skill Level A (professional occupations) or B (technical occupations and skilled trades) on the Canadian National Occupational Classification list, AND you must have had this experience within the last 10 years.

If you meet these minimum requirements, your application will then be processed according to the six selection factors in the skilled worker points grid. The six selection factors are:

- your education
- your abilities in English and/or French, Canada's two official languages
- your work experience.
- your age
- whether you have arranged employment in Canada, and
- your adaptability.

You must also show that you have enough money to support yourself and your dependants after you arrive in Canada

Admission to Canada is governed by the Immigration and Refugee Protection Act and Regulations, a complex set of rules which are subject to interpretation by visa officers who, by law, are the only persons authorized to issue visas to persons who wish to live and/or work in Canada. Immigration to Canada also requires that an applicant make a choice as to the category in which he will apply, be it in the Skilled Worker, Business or Family Class. The correct choice of class, the careful preparation of an application according to current "National Occupation Classification Matrix" backed by an in-depth knowledge of the system can often make the difference between success and failure. 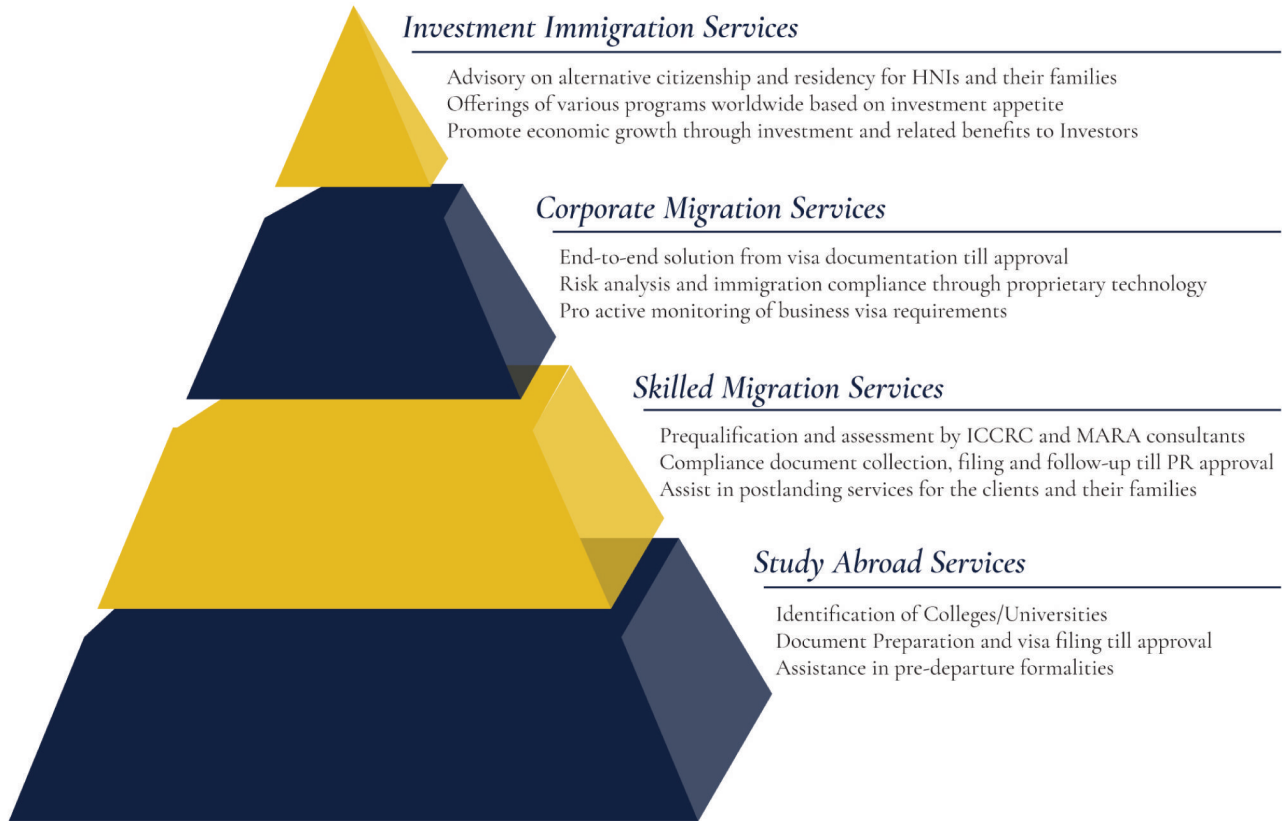

UNITED STATES OF AMERICA



Investment

The EB-5, is the fifth employment-based visa intended to encourage the flow of US capital Economy and to promote employment for US Citizens.

Work

You are eligible to become a permanent resident based on the offer of permanent employment in the United States. Most of the categories require an employer to get a labor certification and then file a Immigrant Petition .

AUSTRALIA

You need to have a qualifying business, or any Direct investment which is made in private Australian companies from which you derive your ownership interest.

The Provisional visa (Sub class 188) is part of the Business Innovation and Investment Programme. The skill select and nomination by the State or Territory government is based on your Expression of Interest for inviting to apply for Business Australian visa.

HONG KONG



Investment

The person who is making entry to Hong Kong is allowed to make his choice of investments amongst permissible assets without the plan of establishing any business or get into any business.

Entrepreneur

Hong Kong has a special immigration visa scheme called Entry for Investment for foreign entrepreneurs who wish to immigrate to operate their own business in Hong Kong.

Work

Applicants who are not non-local graduates but possess special skills, knowledge or experience of value to and not readily available in the HKSAR may apply to come to work.

UNITED KINGDOM



Investment

The Tier 1 visa is provided to you if you have GBP 1 million or more investment funds and you should also prove that this money belongs to you , husband, wife, unmarried or same-sex partner.

Entrepreneur

You allows the Venture Capital Firm to keep a 10% equity stake in the business that the you start in the UK.

Work

You can come to the UK with a Tier 2 (General) visa for a maximum of 5 years and 14 days, or the time given on your certificate of sponsorship plus 1 month, whichever is shorter

CANADA



Investment

The applicant should have alone or with accompanying spouse assets worth CAD\$ 16,000.00 obtained legally excluding the donations less than 6 months before the date on which application was filed.

Entrepreneur

You should have legally obtained a net assets of at least CAD\$ 300,000 wherever applicable if you are married or common law spouse provided he or she is accompanying you.

Work

You can work temporarily in Canada under your Canadian employer. People can work in Canada for a maximum of four years.



EXPRESS VISA FOR CANADA



KEY FEATURES OF EXPRESS ENTRY

With effect from 1st January 2015, Canadian Government has introduced a new process for selection of skilled professionals and tradespersons wishing to immigrate to Canada and live and work in Canada as a permanent Resident. The new Canada skilled immigration selection process introduced by Citizenship and Immigration Canada and called Express Entry to Canada has generated a lot of excitement and rightfully so. Thankfully, with announcement of Express Entry points under comprehensive Ranking system (CRS) and Express entry application process, the applicants can start filing their applications to be filed under Federal Skilled worker Class for immigration to Canada.

Our opinion and view is that this is landmark change and opens door for immigration to Canada for interested Candidates like never before.

[Here are key features of the Canada Express Entry Program:](#)

- The FSW Express entry program to Canada is just changing in selection process and not selection criteria for migrants wanting to settle down in Canada as a skilled worker. So now, the applicants can apply for immigration to Canada only after they are invited to apply under federal skilled worker program by Citizenship and Immigration Canada.
- Invitation is easy to come by for qualified Candidates and will have an additional stage called Express Entry Pool. The application will stay in the pool for one year after which it will be removed and candidate will need to re-enter if continues to be interested.
- There will be a Canada express entry comprehensive Ranking system (CRS) which will be points based on which application will be filed in the pool. Under the CRS, it will be beneficial (in case of married applicants) for both the spouses to offer their IELTS and WES report summaries. Candidate filing the on-line express entry form will be asked to provide information related to his qualifications, experience, occupation, Language skills, Canadian Education, Canadian Experience, Spousal language skills as also presence of any blood relations in Canada. The on-line express entry form will also ask queries related to their preference as regards the province in which they wish to settle down. Please note that the CRS system is not meant to determine your eligibility for Immigration to Canada. To know whether or not you are qualified to apply for skilled immigration, you must meet the eligibility for FSW 67 point's criteria.
- Regular draws will be taken from the pool and Candidates appearing higher in the ranking in the pool will be selected. While those having confirmed job offers will appear higher in ranking and hence may be first to be amongst those selected under Canada FSW express entry program, it is NOT A MUST that a candidate has a confirmed job offer from a Canadian Employer to be eligible to get an invite to apply for PR visa

EXPRESS VISA FOR CANADA



KEY FEATURES OF EXPRESS ENTRY

- Express entry draws will be a highly transparent process and instructions that will be followed to pick out applicants from the express entry pool will be posted on the website of Citizenship and Immigration Canada. The announced instructions will confirm the date of draw as also number of candidates who will be picked out of pool in the specific draw and finally specific Canadian immigration program for which draw from the pool will be conducted. The basis for selection from the express entry pool will be comprehensive Ranking system (CRS).
- Candidates having confirmed job offer are not expected to be many and hence chances for express entry applications filed in the pool, which are without job offer are likely to be extremely bright. What is more, it can happen that after the application is filed in the pool and in the Canada Job Bank, the candidate is chosen by a Canadian employer and given a job offer. In such a situation, the details filed in the Express entry pool through comprehensive Ranking system (CRS) can be updated and thereby immediately move higher in Pool rankings. In the next draw, chances of being picked up from the pool will thereby increase.
- Also once you file your application under the express entry pool, chances of you as a provincial nominee increase! Even a provincial nominee, you will get additional points under the comprehensive Ranking system (CRS), thereby improving chances of moving up in rankings in the pool. In the next draw, chances of being picked up from the pool will thereby increase.
- Under Express entry program is that almost all occupations are now eligible for filing the application under the federal skilled worker program. This is a marked shift from Canadian Skilled Immigration policy of recent years whereby limited number of occupations was opened for applications every year. In addition, there used to be quotas attached to number of applications that could be filed under each of the permitted occupation under federal skilled worker program. All that has changed under the Canada Express Entry. There are no per occupation quotas to deal with only annual quotas for skilled category is what you need to watch out for!
- Candidates who are chosen from the express entry pool must also ensure that they meet the federal points based selection criteria and its requirements. He will then be asked to indicate which of the economic class migrant programs he is making the application under Federal Skilled Worker Class, Canadian Experience Class, Canada Foreign Tradesperson class.
- It has been indicated by Citizenship and Immigration Canada that permanent residence applications of candidates picked up from the pool will be processed within six months of being lodged in for Federal stage. In addition, even federal stage will be an on-line application process unless the candidate suffers from some kind of physical disability.
