

Description The Employment-Based Fifth Preference Immigrant Investor Program, commonly known

as the EB-5 program

It allows individuals who invest in qualifying projects to obtain green cards (US

Permanent Residents)

The EB-5 program is administered by USCIS within the Department of Homeland

Security (DHS)

Investment Criteria Capital Investment: Each EB-5 investor must invest a minimum of \$1 million in a new

commercial enterprise, or \$500,000 if the business is in a targeted employment area (TEA). TEAs are either areas experiencing unemployment at 50 percent above the

national average rate or rural areas.

Job creation: The investment must create or preserve at least ten full-time jobs for U.S.

workers within two years of the investor's admission to the United States.

Process Overview The application process for each foreign investor begins with filing Form I-526 (Petition

by Alien Entrepreneur) to prove eligibility for the EB-5 program

If the investor is approved, they are granted conditional permanent residence for two

years in the United States

Finally, before the expiration of the two-year conditional period, the investor must submit an application to provide evidence that they have met all of the EB-5 program

requirements to remove the conditions on their resident status

Timeline 12 - 14 months to get Conditional Permanent Residence

Benefits of US Citizenship

- No language, education, age or business experience requirements
- The applicants spouse and unmarried children under the age of 21 can obtain permanent residence cards with the investor
- Able to obtain unconditional permanent residency after 2 years
- Ability to apply for citizenship after 5 years of permanent residence if living requirements fulfilled
- Ability to live, work, study and manage a business anywhere in the US
- Excellent education system for the investor's children with little to no tution fees in the public grade schools
