Applications for this program are submitted to the Nauru Economic and Climate Resilience Citizenship Programme (NECRCP). The initiative is controlled by the Nauru Economic and Climate Resilience Citizenship Act.

The NECRCP offers a road to citizenship with a direct donation starting at US\$105,000. Successful candidates are granted visa-free entry to 89 destinations, including the UK and UAE, with a processing time of 3-4 months.

Eligibility

- Minimum age: 18 years.
- No Criminal Record
- Proof of Funds
- Due Diligence Clearance
- Excellent Health Condition

Key Benefits

- A Nauruan passport via citizenship by investment lets Indians and others visit 119 countries visa-free, including the UK, Ireland, UAE, Hong Kong, and Russia.
- The primary applicant and their spouse can pass on dual citizenship to subsequent generations.
- Family members included: spouse, children under 18, unmarried dependents up to 30, parents/grandparents over 55, and unmarried siblings.
- Nauru is one of the easiest countries to obtain citizenship, with candidates able to complete the Nauru citizenship by investment process remotely.



Investment Options

Donation requirements:

- US\$105,000 for a single applicant
- US\$110,000 for a family of two–four members
- US\$115,000 for a family of five or more members
- US\$15,000 for each additional sibling of the main applicant or their spouse

Process

- 1 XIPHIAS walks you through the requirements for Nauru citizenship.
- 2 Complete all application forms; XIPHIAS will send your paperwork to the Program Office.
- 3 Pay all processing, application, and due diligence fees.
- 4 Conduct due diligence checks before attending your virtual or in-person interview.
- 5 Receive government pre-approval after completing due diligence.
- 6 Make the required donation to the Nauru Treasury Fund and provide proof (coordinated by XIPHIAS).
- 7 Take the Oath of Allegiance to get citizenship.
