## About Vanuatu CBI

Applications are submitted to Vanuatu's Citizenship Office and Commission (COC), and the program operates under the Vanuatu Citizenship Act [Cap. 112].

Launched in 2017, it offers one of the fastest routes to citizenship, requiring a minimum donation of US\$130,000 to a local development fund. Vanuatu an 80-island nation in the South Pacific and the only CBI program in the Asia-Pacific region—is also a proud Commonwealth member.

## Eligibility

- Minimum age: 18 years.
- Own a spotless criminal record backed up by current police certifications.
- Not have been denied a visa from a country with which Vanuatu has visa-free agreements
- At least \$250,000 in personal or shared net assets must be demonstrated.

## Investment Options

The following sums of money must be donated to the government in order for the candidate to be eligible for citizenship:

- \$130,000 USD for one candidate.
- \$150,000 USD for the primary applicant and spouse.
- \$165,000 USD for the principal candidate, spouse, and one child.
- \$180,000 for the principal candidate, spouse, and two kids.
- \$10,000 USD for each additional family member who submits an application.

## Process
