About Canada Business Residency

Canada offers provincial pathways for experienced entrepreneurs who want to start, purchase or grow a business. After meeting the province’s business conditions and receiving a nomination, the applicant may apply for permanent residence.

Each province has its own eligibility, investment and business requirements. Applicants are expected to actively manage their business and contribute to the local economy. The selected pathway should match the applicant’s experience, investment capacity and preferred province.

Eligibility

- Business ownership or senior management experience
- Required personal net worth and investment funds
- A practical and viable business plan
- Meet language and provincial programme requirements
- Actively manage the proposed Canadian business
- Intend to live in the province providing the nomination

Business Pathways Across Canada

Canada offers several provincial and territorial pathways for entrepreneurs who want to establish, purchase or operate a business. The right option depends on the applicant's experience, investment capacity, business proposal and preferred destination.

- Alberta: Rural Entrepreneur, Graduate Entrepreneur, Foreign Graduate Entrepreneur and Farm streams.
- British Columbia: Entrepreneur Immigration Base and Regional streams.
- Manitoba: Entrepreneur Pathway and Farm Investor Pathway.
- Atlantic Canada: PEI Work Permit Stream, New Brunswick Business Immigration, Nova Scotia Entrepreneur and Newfoundland & Labrador International Entrepreneur.
- Northern Canada: Northwest Territories Business Stream and Yukon Business Nominee Program.

Note: Programme availability, selection priorities and investment requirements vary by location and may change.

Process

- 1 Profile Assessment**
XIPHIAS reviews your business experience, available funds, language ability and preferred destination.
- 2 Pathway Selection**
We identify the provincial or territorial pathway that best matches your profile and business plans.
- 3 Business Proposal**
A clear business concept or detailed business plan is prepared according to programme requirements.
- 4 Expression of Interest**
Your registration or Expression of Interest is submitted where required.
- 5 Complete Application**
After receiving an invitation, the application, financial evidence and supporting documents are submitted.
- 6 Establish the Business**
Complete the required visit or interview, obtain work-permit support and begin operating the approved business.
- 7 Nomination and PR**
After meeting the business conditions, apply for provincial nomination and permanent residence through IRCC.
