Invest in Curaçao and secure a long-term residence permit through an approved business investment.

About Curaçao Investor Residency

Curaçao offers a dedicated residence programme for genuine foreign investors who want to live on the island for more than six months each year. The investment should support employment, bring foreign currency or contribute to Curaçao’s economic development.

The permit period depends on the amount invested. Applicants may receive residence for three years, five years or an indefinite period while maintaining sufficient funds to meet their investment obligations.

Eligibility

- Be a genuine foreign investor
- Invest at least XCG 500,000
- Hold sufficient independent financial means
- Provide official evidence of the investment
- Support employment or economic development
- Meet the residence application requirements

The first application must generally be awaited outside Curaçao until a decision is issued.

Key Benefits

- Residence permits starting from three years
- Five-year residence at a higher investment level
- Indefinite residence through qualifying investment
- Live in Curaçao for more than six months yearly
- Establish or invest in a local business
- Support employment and economic development



Investor Permit Options

Curaçao provides three residence-permit options for qualifying foreign investors. The appropriate option depends on the investment value, intended residence period and long-term business plans.

- Three-Year Residence: Business investment from XCG 500,000
- Five-Year Residence: Business investment from XCG 750,000
- Indefinite Residence: Business investment from XCG 1,500,000
- Application Fee – Three Years: XCG 1,865
- Application Fee – Five Years: XCG 3,095
- Application Fee – Indefinite: XCG 6,170

The investment should create employment, introduce foreign currency or support Curaçao's economic development

Process

- 1 Profile Assessment**
XIPHIAS reviews your investment capacity, business plans and preferred permit duration.
- 2 Permit Selection**
We identify the three-year, five-year or indefinite residence option suited to your plans.
- 3 Document Preparation**
The application form, passport and supporting investment documents are prepared.
- 4 Investment Evidence**
Official documents showing the completed or intended business investment are collected.
- 5 Fee and Submission**
The applicable government fee is paid and the complete application is submitted.
- 6 Government Decision**
The Admission Office reviews the application and may take up to four months to decide.
- 7 Permit Collection**
After approval, an appointment is arranged to receive the Curaçao residence permit.
