Investment Options

1. Real Estate Investment.

- Invest USD 300,000 in Panamanian real estate to get permanent residency in ~2 months. Applicants must be 18+, have a clean record, and maintain the investment. Family inclusion is allowed, with citizenship possible after 5 years.

2. Stock Market

- Invest USD 500,000 in approved Panamanian securities for permanent residency in 2-3 months. Clean record and maintained investment required. Family included, citizenship eligible after 5 years.

2. Bank Deposit

- Deposit USD 750,000 with a licensed Panamanian bank to secure permanent residency in 2-3 months. Must maintain deposit and clean record. Family included; citizenship possible after 5 years.

Process

- 1 The candidate contacts XIPHIAS for a preliminary eligibility evaluation and advice.
- 2 XIPHIAS helps the applicant complete the qualifying investment and provide all necessary paperwork.
- 3 Authorized local representatives work and submit the application for PR to the Panamanian government.
- 4 The applicant's background, funding source, and investment are all investigated and verified by the Panamanian authorities.
- 5 After being accepted, the candidate is given a permanent resident card and direct permanent status in Panama.
